The city's biggest live village festival - A Thiruvizha by Brand Avatar at the Sathyabama University Grounds, OMR, Chennai.

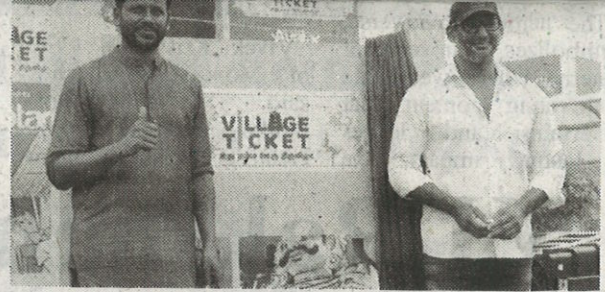
